4. First aid measures

4.1. Description of first aid measures

General

Move victim to fresh air.
Call 911 or emergency medical service if deemed necessary.
Give artificial respiration if victim is not breathing.
Administer oxygen if breathing is difficult.
Remove and isolate contaminated clothing and shoes.

Inhalation

Eyes

Irrigate copiously with clean fresh water for at least 15 minutes, holding the eyelids apart and seek medical attention.

Skin

Remove and isolate contaminated clothing and shoes. In case of contact with substance, immediately flush skin or eyes with running water for at least 20 minutes. Shower and wash with soap and water. Keep victim warm and quiet.

Ingestion

4.2. Most important symptoms and effects, both acute and delayed

Overview

5. Fire-fighting measures

6.3. Methods and material for containment and cleaning up

Remove sources of ignition, do not turn lights or unprotected electrical equipment on or off. In case of a major spill or spillage in a confined space evacuate the area and check that solvent vapor levels are below the Lower Explosive Limit before re-entering.

Large Spill: As an immediate precautionary measure, isolate spill or leak area for at least 50 meters (150 feet) in all directions.

Keep unauthorized personnel away.

Stay upwind.

Keep out of low areas.

Ventilate closed spaces before entering.

7. Handling and storage

7.1. Precautions for safe handling

This product contains solvents. Solvent vapors are heavier than air and may spread along floors. Vapors may form explosive mixtures with air. Areas of storage, preparation and application should be ventilated to prevent the creation of flammable or explosive concentrations of vapor in air and avoid vapor concentrations higher than the occupational exposure limits.

7.2. Conditions for safe storage, including any incompatibilities
